This letter is to notify you of revisions to Title 30 Texas Administrative Code § 101.378 (30 TAC § 101.378), Discrete Emission Credit Banking and Trading. These revisions, adopted on December 13, 2002, now require the Texas Commission on Environmental Quality (TCEQ) to issue a uniquely numbered certificate for all certified DERCs listed in the DERC Registry.

Enclosed is the DERC Certificate numbered D-1054, issued to TXU Generation Company in the amount of 264.6 tons of nitrogen oxide discrete emission credits. This certificate has been deposited in the TCEQ Discrete Emissions Credit Registry. This certificate may be transferred or sold to another owner per the requirements of 30 TAC §§ 101.370 through 101.379. However, the certificate must be submitted to the TCEQ Discrete Emissions Credit Registry when ownership of the credits changes.
