DISCRETE EMISSION CREDIT USE TECHNICAL REVIEW

PROJECT OVERVIEW

The Dow Chemical Company (Dow) submitted a Notice of Use of Discrete Emission Credits (Form DEC-3), received April 1, 2015, postmarked March 30, 2015, for the use of Discrete Emission Reduction Credits (DERC) for compliance with the Mass Emissions Cap and Trade (MECT) Program at the Dow Texas Operations Freeport site for the 2014 control period (January 1, 2014 to December 31, 2014).

Dow intended to use 3,000 tons of nitrogen oxides (NO_x) DERCs in lieu of MECT allowances, at a ratio of 10 DERCs for one allowance, in accordance with 30 Texas Administrative Code (TAC) §101.356(h)(2). Based on the information provided in the Form DEC-3 and the Annual Compliance Report (Form ECT-1) that was received from Dow on April 1, 2015, no DERC-related allowances were needed for the 2014 control period.

A total of 3,000 tons of DERCs were set aside from DERC certificates D-2551 (1,700.9 tons) and D-2768 (1,299.1 tons) in intent project number 409389. Since no DERCs were used, the DERCs set aside from these certificates will be returned to Dow for future use. Because the full amount from each certificate was set aside in the intent project, the DERCs will be returned on the same certificate numbers. No new certificates will be generated.

DISCRETE EMISSION CREDIT USE

Dow had sufficient MECT allowances to cover the 2014 NO_x emissions from the MECT-applicable facilities at the Dow Texas Operations Freeport site. Therefore, no DERC-related allowances were needed. Refer to MECT report project number 410070 for the actual NO_x emissions reported from the Dow Texas Operations Freeport site for the 2014 control period.

CONCLUSION

Dow did not need to use DERCs to cover the NO_x emissions from the Dow Texas Operations Freeport site during the 2014 control period. Therefore, the DERCs set aside in intent project number 409389 will be held for use in intent project number 410311. Certificate D-2551 was issued to Dow on October 16, 2010, and Certificate D-2768 was issued on May 19, 2011.


