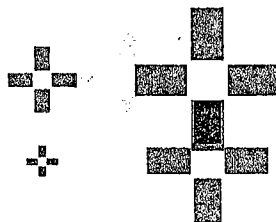

Craig,

I will work on the Form DEC-2 soon. For the Form DEC-4, since I will not be able to transfer the entire amount requested (470.2 of requested amount needed for DEC-2), I suggest the following to minimize the amount of HGB DERCs used or left at Limestone EGS:

- 1) The amount of HGB DERCs needed for Limestone is 799.5 tons (note that the environmental contribution and compliance margin were not rounded up on the DEC-2, so the total amount needed for Limestone is 1936.9 tons).
- 2) Transfer D-2960 to HGB (this is the one from HGB that you previously indicated to use at Limestone).
- 3) Use D-2804 (395.1 tons), D-2758 (242.4 tons), and D-2204 (164.0 tons), totaling 801.5 tons.
- 4) This will leave 2.0 tons of HGB DERCs in the Limestone portfolio after the DEC-2 is processed.
- 5) When the DEC-3 is filed after the use period, specify to use the Limestone-generated DERCs first (D-2522 with 1067.5 tons and D-3015 with 69.9 tons) so that the maximum amount of HGB DERCs will still be available in the Limestone portfolio for transfer back to HGB.

Please respond back today so I can finish processing the DEC-2 and DEC-4.

Craig,

After your conversation with Brandon, I am sending this e-mail to discuss the options that you have for my processing of the DEC-2 for Limestone EGS and the DEC-4 to transfer DERCs from the Limestone EGS portfolio to the HGB System Cap portfolio.

- 1) Process the DEC-2 as it was submitted, setting aside 1936.7 tons of NOx DERCs (1684.1 for emissions, 168.4 for the 10% environmental contribution, and 84.2 for the 5% compliance margin). This will mean that you will not be able to transfer out the entire 7599.1 tons of DERCs generated in the HGB area that were shown on the DEC-4 that was submitted in June (no more than 7129.9 tons could be transferred). The use period for these DERCs on the DEC-2 would be 8/1/2013. When the DEC-3 is submitted and processed, we could use the DERCs from HGB last so that you might have more DERCs that could be transferred to the HGB system cap portfolio later.
- 2) Reduce the amount set aside on the DEC-2 to 1466.5 tons (1275.1 for emissions, 127.6 for the 10% environmental contribution, and 63.8 for the 5% compliance margin). This would allow you to transfer the entire 7599.1 tons from HGB that were shown on the submitted DEC-4. The use period for the DEC-s would still start 8/1/2013.
- 3) Hold off on processing the DEC-2 until East Texas DERCs are transferred into the Limestone EGS portfolio. However, this would affect the start date of the use period (would start 45 days after the new DEC-4 is processed).

Please let me know as soon as possible how you want me to proceed. Your last e-mail (7/30/2013) indicated that you wanted to transfer the full amount of HGB DERCs, but did not confirm that you want to reduce the amount of DERCs set aside for Limestone EGS.
