INTRODUCTION

On January 15, 2013, Mr. Ryan Rector, Environmental Investigator ('Investigator'), of the Texas Commission on Environmental Quality (TCEQ), Dallas/Fort Worth (DFW) Region office, conducted a Permit Provision Review (PMPR) investigation for the Hanson Brick Mineral Wells Facility ('regulated entity' or 'site'), which is owned by Hanson Brick East, LLC ('Hanson'). The site is located at 500 Northeast 14th Avenue, Mineral Wells, Palo Pinto County, Texas.

This investigation was conducted in response to a request for comments, which was received from TCEQ Air Permits Division (APD) on January 14, 2013. The request for comments was





regarding an amendment to New Source Review (NSR) Permit Number 9572, which was submitted to APD by Hanson. Hanson is proposing to replace an existing hammermill with a larger capacity hammermill without increasing throughput. The purpose of this investigation was to review permit draft conditions and provide comments to APD staff. Ms. Kititke Cook was the Permit Reviewer assigned to this project. This investigation was conducted in the office, by reviewing the draft permit conditions provided by APD.

#### **Daily Narrative:**

The amendment of Permit No. 9572 was reviewed, and recommendations were made based on information provided in the permit application, as well as records kept in the TCEQ file for the company. Mr. Rector evaluated the permit draft conditions and found no objections to the continuation of the permit amendment. A response to the request for comments was provided to Ms. Cook via email on January 15, 2013.

#### Exit Interview:

No exit interview was conducted for this site assessment file review.

#### GENERAL FACILITY AND PROCESS INFORMATION

#### **Process Description:**

Operations at this plant involve the manufacturing of bricks consisting of clay grinding, screening, storage and brick forming, drying, firing, sorting, and shipping. Hanson MWF loads and screens clay material which is then conveyed to a mixer, re-claimer bunkers and a re-claimer. The clay material then goes into a surge bin and weigh feeder. Pigments, body additives, and scraps are added to the material before the mixture is fed to a hopper and then into a pugmill. In the pugmill, water is added to the mixture to give the clay plasticity. Bricks are formed via extrusion through a dye in a continuous strip. Colored sands may be applied and textures are formed on some of the bricks. The slug then enters the setting machine where it is cut into individual bricks. The bricks are then loaded onto kiln cars and transported into kilns. In the kilns, they are dried and fired before being classified and packaged.

#### **BACKGROUND**

#### Compliance History Rating

The regulated entity (RN102315827) has a compliance history rating of 11.25 and a performance classification of satisfactory. The customer (CN602627333) has a compliance history rating of 1.92 and a performance classification of satisfactory.

#### **Current Enforcement Actions:**

No violations were noted as a result of this assessment.

#### Agreed Orders, Court Orders and Other Compliance Agreements:

Agreed Order, TCEQ Docket No. 2010-1470-AIR-E; Enforcement Case No. 40353 resulted from a Notice of Enforcement (NOE) dated August 30, 2010. The Agreed Order will terminate on March 7, 2016.

#### **Prior Enforcement Issues:**

An NOE was issued to Hanson on August 30, 2010, for failure to submit a certification of compliance with the terms and conditions under Title V FOP No. O-01692 at least each 12-month period in violation of 30 TAC §122.146(1) and 30 TAC §122.146(2). The Agreed Order noted above was a result of this alleged violation.

#### Complaints:

A review of the region files indicates there have been no air quality related complaints filed against this entity in the five years prior to this site assessment.

#### ADDITIONAL INFORMATION/RECOMMENDATIONS

#### Conclusions and Recommendations:

No objections to the continuation of the permitting process were noted during this assessment.
