Texas Municipal Power Agency, submitted a Form DEC-1, Notice of Generation and Generator Certification of Discrete Emission Credits on September 12, 2005, for the generation of DERC credits. The generation was to come from the instillation of Low NO_x burners on a Sub-bituminous coal fired boiler.

However, after receiving this request the copy of the DEC-1 was misplaced. Attempts to get another copy was not answered, the request was tabled, eventually falling into the team backlog. The technical contact at that time was Mr. Patrick Marz,

In an attempt to clear backlogs the customer was contacted on 02/17/2009 and informed of the status of the project, Mr. Chang the new technical contact, who had just taken over the position with the company, informed me that he had several boxes of papers that he would have to look through.

On 02/19/2009 a follow up call was made to Mr. Chang and he informed me that there were other pressing environmental issues. We agreed that he would contact me as soon as he could find the time to look for the requested documents.

On April 8, 2009 Mr. Chang contacted me and informed me that he could find no copies, nor any documentation to support the request. Therefore without the DEC-1, or any of the supporting data this request can not be completed.

As a result, project 400857 will be voided and a letter stating that the request cannot be completed will be sent to Texas Municipal Power Agency.
