The Texas Commission on Environmental Quality (TCEQ) has reviewed the above referenced DWSR Addendum, dated June 27, 2018. The DWSR Addendum stated that two water wells were listed in the database within approximately 500 feet of the site boundary. The report states that a field reconnaissance did not locate the wells, the staff at the properties were unaware of any on-site wells, and both properties are served by a municipal water source. Additionally, the DWSR Addendum indicates that drinking water for the site and surrounding area is provided by the City of Houston public water supply.
