Dear Mr. Kiltz:

The Texas Commission on Environmental Quality (TCEQ) has reviewed the Drinking Water Survey Report (DWSR), dated February 7, 2019. The DWSR stated that no private/public drinking water wells were found to be located within one-half mile of the subject property, except for one well (state well No. 3310406) located 0.4-mile north of the site which was plugged and abandoned on March 15, 2017. Additionally, the DWSR indicates that drinking water for the site and surrounding area is provided by the City of Dallas municipal water supply.

The TCEQ does not consider the vertical and lateral extent of the contaminated groundwater at the site to be delineated. If a groundwater contaminant plume subject to Texas Water Code (TWC) §26.408 is currently being further delineated, a DWSR addendum needs to be submitted when additional information is available. Based upon our review, the TCEQ conditionally approves of the DWSR.
