The Texas Commission on Environmental Quality (TCEQ) has reviewed the IOP application submitted pursuant to §361.753(c) of the Texas Solid Waste Disposal Act and has determined that the application is complete. The TCEQ will begin reviewing the *Phase I Environmental Site Assessment, Indoor Air Quality Report, Limited Subsurface Investigation* and the *Site Investigation Report* (SIR) submitted with the application and will forward any comments concerning the review to your attention.

Pursuant to 30 Texas Administrative Code §333.36, the applicant is required to provide notice of the application by certified mail, return receipt requested, to property owners adjacent to the site. An example of a notification letter that contains the required information for adjacent property owner notification is enclosed. The applicant should provide the TCEQ with a copy of each delivered notification letter and a copy of each of the signed certified mail receipts upon their return to the applicant.

Please note, to be eligible for an IOP Certificate, in accordance with RG-382, an applicant must be a current *owner* or *operator* of the subject site. Therefore, Applicant C is ineligible and will not be listed if an IOP Certificate is issued.

Future submittals should be mailed to my attention at the TCEQ, mail code MC-221, at the letterhead address. Please provide one paper copy and one electronic copy (on USB or disc) of all submittals. This letter was prepared to inform you that an IOP application has been submitted to the Texas Commission on Environmental Quality (TCEQ) by [IOP Applicant], the [current/prospective] owner/operator of [Name of IOP Site], the IOP site, located at [IOP Site Address], which is adjacent to your property located at [Adjacent Property Address]. The application was submitted in response to the discovery of [type of contamination] in [media type] on [Name of IOP Site]'s property, which the owners/operators contend has migrated to their property solely from an off-site source.

The law creating the IOP became effective September 1, 1997 and was drafted to provide immunity from liability under the Texas Water Code and Health and Safety Code for owners/operators of property that has been contaminated solely by an off-site source. The law also provides for issuance of a certificate confirming the person is an innocent owner/operator and thereby not liable for the contamination if the person makes an adequate demonstration to the TCEQ that the contamination has migrated from an off-site source and that activities on the property did not contribute to the contamination. The [current/prospective] owner/operator of [Name of IOP Site] has submitted an application and site investigation report for TCEQ review requesting an evaluation of information they believe will support their status as an innocent [owner and/or operator].
