PROJECT SUMMARY

B. J. Tidwell has submitted an application for a streamlined minor revision to their Site Operating Permit O1080. The revision reflects a new process line constructed at the site.

REVISION DESCRIPTION

A new cabinet coatings process line was constructed from new equipment and a rearranging of some existing equipment. This new process line and its applicable requirements will be codified in the existing SOP by this revision. Also, a change to the requirements was made on the existing PRONEW line based on a change to method of determining compliance.

PROCESS DESCRIPTION

The process line, consisting of several spray booths and coating operations, coats the various surfaces of kitchen and bath cabinets made at the plant. Booth exhaust and other hood ducts draw the overspray and resulting VOC emissions to a catalytic oxidizer.

TECHNICAL REVIEW

The new process line is subject to 40 CFR Part 63, Subpart JJ. Attributes of this new process line (PRONEW05) result in compliance with this MACT by using compliant coatings.

While reviewing this new process, a quick look at one of the existing process lines (PRONEW) led to a change in MACT JJ requirements in this project. This was due to the determination that: although there was a control device present for the NSR permit, it was not being used for purposes of complying with MACT JJ. Therefore, the attributes for MACT JJ reflecting the presence of a control device (for purposes of MACT JJ compliance) was deleted, and requirements were adjusted to reflect this change.
