This is in response to your letter dated August 8, 2001 concerning the operation of a Homopolymer Conveying Systems at your facility located at 1705 Oliver Street in Houston, Harris County. We understand that the system is equipped with fabric filter having a filtering velocity of 3.36 feet per minute for lines 3 and 3A and 3.7 feet per minute for lines 1 and 2. Also, the systems are closed loop back to the silo and silo dust collection system resulting in an enclosed system

After evaluation of the information which you have furnished, we have determined that the overall operation of this facility conforms to the requirements of permitting by rule authorized under Title 30 Texas Administrative Code Section 106.393 (30 TAC § 106.393) if operated as described in your registration request. This permit by rule was authorized by the Texas Natural Resource Conservation Commission (TNRCC) pursuant to 30 TAC Chapter 106.

A copy of this permit by rule in effect at the time of this registration is enclosed. You must operate this facility in accordance with the version of the permit by rule in effect when operation actually begins (see 30 TAC § 106.4[a][5]). After completion of construction, the facility shall be operated in compliance with all applicable conditions of the claimed permit by rule and 30 TAC § 106.4.

You are reminded that regardless of whether a permit is required, these facilities must be in compliance with all rules and regulations of the TNRCC and of the U.S. Environmental Protection Agency at all times.
