You may resubmit, with appropriate corrections, a revised letter, and/or a new permit by rule registration request (PI-7), or a permit/amendment application (PI-1). Please include all previously-assigned Texas Natural Resource Conservation Commission Account ID, permit, or permit by rule registration numbers in your new submittal.

You are reminded that Sections 382.0518(a) and 382.057 of the Texas Clean Air Act, Texas Health and Safety Code, Chapter 382, provide that a construction permit must be

obtained or a permit by rule fully complied with before work is begun on the construction of a new facility or modification of an existing facility that may emit air contaminants.
