Dear Mr. Surface:

This is in response to your request to register the pending installation of four hot water boilers in the Reliant Park Central Plant at 8194 North Stadium Drive in Houston, Harris County. We understand that the units will operate with natural gas only and that you have elected to make the hours of operation federally enforceable, by submitting a form PI-8. The total emissions associated with these facilities are 12.54 tons per year (tpy) of carbon monoxide, 6.27 tpy of nitrogen dioxide, 0.000011 tpy of sulphur dioxide, 0.72 of hydrocarbons, and 0.18 tpy of particulate matter with less than 10 micron diameter.

After evaluation of the information which you have furnished, we have determined that your proposed installation is authorized under 30 Texas Administrative Code (TAC) Section 106.102 if installed and operated as described in your registration request. This permit by rule was authorized by the Texas Natural Resource Conservation Commission (TNRCC) pursuant to 30 TAC Chapter 106.

A copy of the permit by rule in effect at the time of this registration is enclosed. You must install in accordance with the version of the permit by rule in effect when operation actually begins (see 30 TAC §106.4[a][5]). After completion of installation, the facilities shall be operated in compliance with all applicable conditions of the claimed permit by rule and 30 TAC §106.4.

You are reminded that regardless of whether a permit is required, these facilities must be in compliance with all rules and regulations of the TNRCC and of the U.S. Environmental Protection Agency at all times.
