Dear Mr. Brosseau:

This is in response to the letter on your behalf from Pollution Solutions dated March 12, 2001 concerning the proposed Type IV landfill near the intersection of U.S. Highway 380 and U.S. Highway 75 east of McKinney in Collin County. We understand that this landfill will comply with the Solid Waste Disposal Act. We further understand that as a Type IV landfill as defined in 30 Texas Administrative Code (TAC) Section 330.41, this facility will accept only brush, construction-demolition waste, and rubbish that is free of putrescible and household wastes and that the nearest public road is at least 300 yards away.

After evaluation of the information which you have furnished, we have determined that your project is exempt from permit procedures under 30 TAC Section 106.534 if constructed and operated as described in the letter. This permit by rule was authorized by the Texas Natural Resource Conservation Commission (TNRCC) pursuant to 30 TAC Chapter 106.

A copy of the permit by rule in effect at the time of this registration is enclosed. You must construct, install, or modify the facility in accordance with the version of the permit by rule in effect when construction, installation, or modification actually begins (see 30 TAC §106.4[a][5]). After completion of construction, installation, or modification, the facility shall be operated in compliance with all the applicable conditions of the claimed permit by rule and 30 TAC §106.4.

You are reminded that regardless of whether a permit is required, these facilities must be in compliance with all rules and regulations of the TNRCC and of the

U.S. Environmental Protection Agency at all times.
