This is in response to your letter dated March 21, 2001 concerning the proposed ship painting at Berry Dock West at the Port of Corpus Christi in Nueces County. After evaluation of the information which you have furnished, we have determined that your project is exempt from the permit procedures under 30 Texas Administrative Code (TAC) Section 106. We understand that the ship will be docked at the Port of Corpus Christi for repair work. The painting will be done from a barge and no support from the on-shore facility is required. Drop clothes will be draped to prevent paint from falling into the water. All painting will be done with rollers and brushes, no spraying equipment will be used.

You are reminded that regardless of whether a permit is required, these facilities must be in compliance with all rules and regulations of the TNRCC and of the U.S. Environmental Protection Agency at all times.
