McAllen Economic Development Corporation, pursuant to Article 4.06 of the Texas Non-Profit Corporation Act, hereby adopts Amended and Restated Articles of Incorporation which accurately copy the Articles of Incorporation and all amendments thereto that are in effect to date and such Amended and Restated Articles of Incorporation contain all changes in all provisions thereof.

ARTICLE TWO

The Amended and Restated Articles of Incorporation were adopted in the following manner:

The Amended and Restated Articles of Incorporation were adopted at a meeting of the board of directors held on January 20, 2005, and received the vote of a majority of the directors in office, there being no member having voting rights.

ARTICLE THREE

- 1. The Corporate name has changed from McAllen Economic Development Corporation to McAllen Foreign Trade Zone, Inc.
- 2. The Corporate purposes in Article IV have been amended.

- 5. The phrase "or its successor corporation" in prior Article IX has been deleted.

ARTICLES OF INCORPORATION

MCALLEN FOREIGN TRADE ZONE, INC.

We, the undersigned natural persons over the age of 18, acting as incorporators, adopt the following Articles of Incorporation of McAllen Economic Development Corporation.

ARTICLE I

The name of the corporation is McAllen Foreign Trade Zone, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is a non-profit corporation incorporated under the Texas Non-Profit Corporation Act.

ARTICLE IV

The purpose or purposes for which the corporation is organized are:

(a) To apply for and accept the grant for a Foreign Trade Zone and Sub-Zones; to organize, establish, operate, maintain and expand a Foreign Trade Zone and SubZones under the Foreign Trade Zone Act, Public Law 397, 73rd Congress as amended by Public Law 566, 81st Congress and as further amended, and all related enterprises (the "Business") and to enter

into contracts and agreements with private and public agencies and persons in the conduct of its Business. (Partial Description of Corporate Powers)

(b) To acquire all such merchandise, supplies, materials, vehicles and other articles as shall be necessary or appropriate to the Business; to purchase, acquire, hold, improve, sell, assign, mortgage, lease and convey real and personal property in any part of the world, so far as necessary or appropriate in conducting the Business of the corporation; and to have and hold any and all powers above set forth as fully as any natural persona, whether as principal, agent or otherwise.

ARTICLE V

The street address of the registered office of the Corporation is 6401 S. 33rd Street, McAllen, Texas 78503 and the name of its initial registered agent at such address is MICHAEL ALLEN.

ARTICLE VI

The Corporation will have no members.

ARTICLE VII

The management of the Corporation is vested in its Board of Directors and such committees of the board that the board may, from time-to-time, establish. The bylaws will provide the qualifications, manner of selection, duties, terms, and other matters relating to the Board of Directors.

ARTICLE VIII

ARTICLE IX

ARTICLE X

In the event of dissolution, or upon final liquidation of this Corporation all assets of the Corporation remaining after payment of its debts shall be distributed to the City of McAllen, Hidalgo County, Texas.

ARTICLE XI

Except as these Articles otherwise provide, the Corporation has all of the powers provided in the Texas Non-Profit Corporation Act. Moreover, the Corporation has all implied powers necessary and proper to carry out its express powers.

ARTICLE XII

Any margins realized from operations in excess of those needed to defray operating overhead and maintenance expenses, as well as debt service and the establishment of reserves for recognized corporate purposes, shall be devoted exclusively to the furtherance of the corporate purposes set out in Article IV hereof. No dividends shall be paid by this Corporation and no part of the income of the Corporation shall be distributed to its directors or officers. The Corporation may reasonably compensate directors and officers for services rendered to or for the Corporation in furtherance of one or more of its purposes. The Corporation may not take any action prohibited by the Texas Non-Profit Corporation Act. The Corporation may not take any action that would be inconsistent with the requirements for a tax-exemption under Internal Revenue Code 501 (c)(6) and related regulations, rulings, and procedures. Directors and officers are not liable to the Corporation or to other directors and officers for monetary damages for any act of omission in their capacity as director or officer except as otherwise provided by Texas statute.





ARTICLE XIII

Any amendment of Article IV, Article VII or Article X of these Amended and Restated Articles of Incorporation must be approved by the City Commission of the City of McAllen.

I am an officer of the Corporation and I execute these Amended and Restated Articles of Incorporation on the Corporation's behalf on December 28, 2005 to be effective December 31, 2005.
