WHEREAS, by final decree of the 51st District Court of Tom Green County, in Cause No. 44-031-A, In Re: The Adjudication of Water Rights in the Upper Colorado River Segment of the Colorado River Basin, dated September 10, 1976, a right was recognized under Certified Filing No. 12 authorizing E. H. and Sibyl Forgy to appropriate waters of the State of Texas as set forth below;

WHEREAS, by a Release and Assignment dated November 12, 1975, recorded in Volume 449, Page 144 of the Deed Records of Runnels County, the Veterans Land Board for the benefit of J. B. Dankworth acquired part of the water right.

NOW, THEREFORE, this certificate of adjudication to appropriate waters of the State of Texas in the Colorado River Basin is issued to J. B. Dankworth, his heirs and assigns, subject to the following terms and conditions:

1. USE

Owner is authorized to divert and use not to exceed 45 acre-feet of water per annum from the Colorado River to irrigate a maximum of 61 acres of land out of 2 tracts, tract number one being a 62.77-acre tract in the Francis Helmer Survey No. 417, Abstract No. 247 and tract number two being a 25-acre tract in the Thomas Largent Survey No. 366, Abstract No. 357, Runnels County, Texas, said 62.77-acre tract and 25-acre tract described as follows:

1. BEGINNING at a point on the S bank of the Colorado River located N 73° 33' W, 151.4 varas from the NW corner of said Survey No. 417;

18. THENCE southwesterly 108.3 varas following the N right-of-way of highway to a point;
19. THENCE southwesterly 72 varas along a curve of the right-of-way of highway to a point;

20. THENCE N 59° 58' 21" W, 18 varas to a point;
21. THENCE N 1° 14' W, 34.5 varas with the right-of-way line to a point;

TRACT NO. 2

1. BEGINNING at a point on the N bank of the Colorado River that is N 64° E, approximately 827 varas from the SW corner of said Survey No. 366;
2. THENCE N 30° E, 822 varas to a corner of this tract;
3. THENCE S 60° E, 108 varas;
4. THENCE S 36° E, 222 varas to a point on the river bank;
5. THENCE up the river with its meanderings to the place of beginning.

2. DIVERSIONS

(a) Point of Diversion: At a point on the S bank of the Colorado River which is N 72° E, 1200 feet from the NW corner of the Francis Helmer Survey No. 417, Abstract No. 247, Runnels County, Texas.

(b) Point of Diversion: At a point on the N bank of the Colorado River which is N 57° 30' E, 4000 feet from the SW corner of the Thomas Largent Survey No. 366, Abstract No. 357, Runnels County, Texas.

(c) Maximum Diversion Rate: 3.00 cfs (1350 gpm).

(d) The diversion rate is the combined maximum rate of diversion for Certificate of Adjudication Nos. 14-1080 and 14-1081.

3. PRIORITY

The time priority of owner's right is November 25, 1913.

The locations of pertinent features related to this Certificate are shown on Page No. 22 of the Upper Colorado River Certificates of Adjudication Maps, copies of which are located in the offices of the Texas Water Rights Commission and the office of the County Clerk.



This certificate of adjudication is issued subject to the Rules of the Texas Water Rights Commission and its continuing right of supervision of State water resources consistent with the public policy of the State set forth in Water Code §1.003.

This water right is appurtenant to and is an undivided part of the above-described land within which irrigation is authorized. A transfer of any portion of the land described includes, unless otherwise specified, a proportionate amount of the water right owned by the owner or seller at the time of the transaction.
