The Texas Commission on Environmental Quality (TCEQ) has received your notification dated December 11, 2024, in accordance with Texas Water Code § 5.587 for the above-referenced authorization.

A person who holds a temporary permit or permit with an indefinite term shall report to the commission annually whether the activity subject to the permit is ongoing. As long as this authorization remains active, the owner or operator must report the operational status of the permitted activity by December 31st each year.

If this authorization is no longer active, the owner or operator should submit a void request for the authorization. The TCEQ requires using the online TCEQ e-Services system at www.tceq.texas.gov/agency/tceqonline-services for Air Permitting Void Request.
