FORM CNA-2 APPLICATION FOR CAIR NOX ALLOWANCES FROM THE JUINING DIVISION NEW UNIT SET-ASIDE TRADING BUDGET FORM AND INSTRUCTIONS

General:

In accordance with Title 30 Texas Administrative Code § 101.506 Part (d) (30 TAC § 101.506(d)), an owner or an operator of any stationary, fossil fuel-fired boiler or stationary, fossil fuel-fired combustion turbine meeting the applicability requirements under 40 Code of Federal Regulations (CFR) Part 96 and/or Part 97, Subpart AA, that commenced operation on or after January 1, 2001, and that has not established a baseline heat input in accordance to 30 TAC § 101.506(b)(2) or (3), can receive a Clean Air Interstate Rule nitrogen oxides (CAIR NOx) allowance allocation from the new unit set-aside trading budget, with a trading budget not to exceed 17,196 CAIR NOx tons during phase I (2009 through the 2014 control periods). CAIR NOx allowances will not be allocated from the CAIR NOx new unit setaside trading budget to units during their first control period in which the CAIR NOx unit commences commercial operation. Also, the amount of CAIR NOx allowances requested from each unit must not exceed the total tons of NOx emissions reported to the Environmental Protection Agency (EPA) from the previous control period. Completed Form(s) CNA-2 can be mailed to the Texas Commission on Environmental Quality (TCEQ), Air Quality Division, Emission Banking and Trading Program MC-206, P.O. Box 13087, Austin, Texas 78711-3087. Accepted requests for CAIR NOx allowances from the new unit set-aside trading budget will either be allocated to every site in full, or will be proportionally allocated to every site according to TAC § 101.506(d)(4). Any remaining allowances from the CAIR NOx new unit set-aside trading budget will be allocated to CAIR NOx units receiving an allocation of allowances from the general pool, in accordance to TAC § 101.506(e).

NOTE: Form CNA-2 must be submitted on or before May 1 within each control period. The Texas Commission on Environmental Quality (TCEQ) will then submit to the EPA, no later than October 31 of each year, the CAIR NOx allowances for the current control period from the new unit set-aside trading budget.

Specific:

I. Company Identifying Information

- A. <u>Company Name</u>: Enter the legal name of the company. The company name provided should match the TCEQ Core Data Form.
- B. <u>Mailing Address</u>: Enter the company mailing address, telephone number, and fax number of the owner or operator of the site.
- C. <u>Operator of the Site</u>: Enter the name of the site operator. The site operator name should match the TCEQ Core Data Form.
- D. <u>TCEQ Customer Identification Number (CN)</u>: Enter the TCEQ assigned number of the owner or operator of the site. The CN is a unique number assigned to the company or corporation and applies to all facilities and sites owned or operated by this company or corporation. A typical example of a CN is CN600123456. If you have not been officially notified by the TCEQ Central Registry Program of your Customer Number, or have any questions about your Customer Number, you may call (512) 239-5160 for assistance to obtain or verify the account number.
- E. <u>Site Name</u>: Provide the site name and street address for the facility with the applicable CAIR NOx unit(s). If no street address is available, provide written driving directions. Identify the location by distance and direction from well-known landmarks such as highway intersections. Enter the city or town where the site is located. If the address is not located in a city or town, enter the city or town closest to the site even if it is not located in the same county as the site. Enter the county where the site is physically located. Include the zip code for the physical location of the site.

- F. <u>TCEQ Regulated Entity Number (RN)</u>: Enter the TCEQ assigned number of the site identified in Subsection E. The RN replaces the former TCEQ air account number for the facility or site. A typical example of a RN is RN100123456. If you have not been officially notified by the TCEQ Central Registry Program of the Regulated Entity Number, or have any questions about your Regulated Entity Number, you may call (512) 239-5160 for assistance to obtain or verify the account number.
- G. <u>TCEQ Air Account Number (*if applicable*)</u>: Enter the TCEQ assigned air account number for the site. A typical example of a TCEQ air account number is HG-1234-J.
- H. <u>CAIR Compliance Account Number</u>: Enter the twelve digit CAIR account number. The first six digits are the ORIS/facility code, and the second six digits are "FACLTY". A typical example of a CAIR compliance account number is 012345FACLTY. The submitted CAIR compliance account number must be associated with every submitted Federal Unit ID. One CAIR compliance account number per Form CNA-2, please.

II. CAIR Designated Representative Contact Information

A. <u>Name and Title</u>: Provide the name, title, address, telephone number, fax number, and e-mail address of the CAIR designated representative registered with the EPA.

III. Alternate CAIR Designated Representative Contact Information

A. <u>Name and Title</u>: If an alternate CAIR designated representative is registered with the EPA, please provide this person's name, title, address, telephone number, fax number, and e-mail address.

IV. List of Applicable CAIR NOx Units

- A. <u>Federal Unit ID</u>: Enter the unique identification number for each applicable CAIR NOx unit from the site. It is an alphabetical, numeric, or alphanumeric designation that may be from one to six characters in length.
- B. <u>Online Year</u>: Enter the first control period year in which each CAIR NOx unit commenced commercial operation.
- C. <u>NOx Tons Reported to the EPA</u>: Enter the previous control period's total reported NOx tons to the EPA, in tons. Attach supporting documentation, such as a printout of data from the EPA's Clean Air Markets Division database.
- D. <u>Requested CAIR NOx Amount:</u> Enter the requested amount of CAIR NOx allowances for each unit, in tons. This amount cannot exceed the reported amount in Subsection C.

NOTE: After the final request is accepted by the executive director, the equation found in TAC § 101.506(3)(d) will be used if the total requested amount exceeds the CAIR NOx new unit set-aside trading budget.

V. Certification by Authorized CAIR Designated Representative

The CAIR designated representative or the alternate CAIR designated representative registered with the EPA must sign and date the Form CNA-2 and submit the form to the TCEQ with an original signature and date, in ink, by the representative identified in Section II or Section III.
